Reports of Officers:

- Self-Management Report presented by the President (detailed list below).
- Vice President, Secretary, and Member-at-large had nothing to report.

Reports of Council:

• Treasurer presented a quick update of financials. We have \$552,000, \$109,000 in operating. When replacing windows and doors, changes were made that will extend the life and save money for future maintenance. The Audit and the Capital Reserve Study are in progress; when they are received they will be approved by the Council and then posted on the website.

Committee Reports:

• Nomination Committee Report made by Jeanne B., Chairperson. The committee met twice. They received 2 bios from current council member wishing to run again; no others were received. The 2 bios were accepted. The council will have to appoint a new chairman if Jeanne decides to run again.

After some discussion, motion made to accept the reports by John S. and seconded by Kathy F.. No further discussion; motion was passed.

Appointment of Election Officials: Susan O., Marie M., Dick O., Kathy F., and John C. were appointed and sworn in as officials. The President then explained what their duties were.

Election to fill two (2) vacant positions: There are 2 nominations accepted by the nominating committee. Hilary F. nominated Joanne W. and she accepted. The 3 candidates introduced themselves. A motion was made to close the nominations by John S. and seconded by Hilary F.. No further discussion; motion was passed.

Election officials proceeded to tally up the votes while we moved on with the meeting.

## Unfinished Business:

There was an extensive discussion regarding the propane tanks.

New Business:

A motion was made by Pat H. that since the fax machine is at John D.'s home, the fax number should not be listed on any election proxy, it was seconded by Hilary F. Motion passed.

Vice President read the results of the election. The total count was questioned and the votes were recounted and the results were as follows (see addendum at end):
