DE Code Title 8 Section 232 (2017) a) Without limiting the manner by which notice otherwise may be given effectively to members any notice to a member given by the corporation under any provision of this chapter, the certificate of incorporation, or the bylaws shall be effective if given by a form of electronic transmission consented to by the stockholder to whom the notice is given. Any such consent shall be revocable by the member by written notice to the corporation. Any such consent shall be deemed revoked if (1) the corporation is unable to deliver by electronic transmission 2 consecutive notices given by the corporation in accordance with such consent and (2) such inability becomes known to the secretary or an assistant secretary of the corporation or to the transfer agent, or other person responsible for the giving of notice; provided, however, the inadvertent failure to treat such inability as a revocation shall not invalidate any meeting or other action.

- (b) Notice given pursuant to subsection (a) of this section shall be deemed given:
- (1) If by facsimile telecommunication, when directed to a number at which the member has consented to receive notice;
- (2) If by electronic mail, when directed to an electronic mail address (email) at which the member has consented to receive notice;
